ADMISSION PROCEDURE:-

A. ONLINE REGISTRATION FOR COUNSELLING:

The applicants are required to register themselves online on <u>www.mcc.nic.in</u> / Ministry of Health & Family Welfare (Govt. of India) to participate in Counselling of UG (MBBS/BDS) courses for the Academic Year 2025-2026 for both 85% Delhi Quota and 15% All India Quota.

B. <u>Admissions (After successful allotment of MBBS/BDS seats by MCC for 85% Delhi Quota and 15% All</u> <u>India Quota):</u>

1. Only those applicants who are allotted seats in Colleges affiliated to University of Delhi after successful allotment of seats by the MCC, DGHS, Ministry of Health & Family Welfare (Government of India) are required to register themselves on the online admission portal on the official website https://fmsc.du.ac.in of Faculty of Medical Sciences through online link* for admission to MBBS/BDS for 85% Delhi Quota and 15% All India Quota after verification of their documents by the respective colleges. They are required to complete the registration by uploading their documents, photograph, signatures and the online payment of registration Fee.

- * Online link will be provided later on the official website of Faculty of Medical Sciences i.e. https://fmsc.du.ac.in under Course updates UG (MBBS/BDS).
- 2. Before initiating the registration for admission, the applicants are advised to refer to UG (MBBS/BDS) Bulletin of Information-2025 thoroughly.
- 3. Any applicant, who has not been allotted any seat in University of Delhi under 85% Delhi Quota and 15% All India Quota or if otherwise ineligible to register for admission, somehow registered himself/herself on https://fmsc.du.ac.in, in such cases their registration will be invalid and no refund of fee will be done under any circumstances.

(b) Online registration details for admission to the Under-graduate (MBBS/BDS) courses are as under:

- As a first time user, the applicant shall create the login details.
- In the "Confirm your Information" webpage, applicant shall provide the NEET-UG-2025 Roll No. and Date of Birth. Clicking on "View" button will display further details of the applicant.
- If the details are correct, applicant can click "Confirm" and proceed further.
- On the "New Registration" page, the applicant has to enter a valid Mobile No. and Email ID which would be used for any future communication with the University for admission purpose.
- The Applicant shall then create a password (of maximum six characters) for online registration purpose. This password does not need to be same as applicant's email account password, which is used to access one's email account.
- Applicant shall provide a valid mobile phone number (10 digit number without any prefix).
- Please verify that all the details given in the form are correct. This information will be used during the entire admission process. No change/modification is allowed. Please be careful in filling up the required information in allaspect.
- (c) Applicant shall now log on to using "registered email-id" and created "password" to fill the online registration form.
- (d) Applicant shall click the "Save" and proceed to check the details filled in the form.

2. <u>Duration of Courses</u>:

MBBS Course:

The normal duration of the course is 4½ years, followed by one year compulsory rotating Internship Training.

BDS Course:

The duration of the course is 4 years, followed by one year compulsory rotating Internship Training.

3. <u>Eligibility Conditions/Requirement for admission to MBBS/BDS</u> <u>Courses</u>

(a) Age: The applicants should have completed the age of 17 (seventeen) years on or before 31st December 2025. The applicants completing the age of 17 years on 1st January 2025 or later on will not be eligible for admission, i.e., the applicant must be born on or before 31.12.2007.

(For details please refer to the Bulletin of Information to Undergraduate Medical Courses of National Eligibility cum Entrance Test (NEET – UG 2025)

(b) <u>Qualifying examination</u>:

- (i) The educational qualification for admission is as per NEET conducted by National Testing Agency (NTA). Further to become eligible for 85% Delhi Quota, the applicant must have passed 11th and 12th standard examination under 10+2 system conducted by CBSE/Indian school certificate examination/Jamia Millia Islamia, New Delhi or any other equivalent examination from a recognized school situated within the NCT of Delhi only. (see Appendix I)
- (ii) The Applicants who have passed qualifying examination from **Patrachar Vidyalaya or National Institute of Open Schooling** will be eligible for admission in MBBS/BDS courses under 85% Delhi Quota provided their study center and the examination Center were within the National Capital Territory of Delhi (NCTD) and they must upload a certificate from the controlling authority of Patrachar Vidyalaya/NIOS in this regard.

4. Nominee of Govt. of India (NGOI/Central Pool Scheme):

(a) Twenty One Seats (6-MAMC + 15-LHMC) in MBBS Course will be filled up on the basis of recommendations of the Ministry of Health & Family Welfare, Govt. of India, New Delhi. These recommendations are made by the Ministry for the names sponsored by various authorities as given below. The eligible applicants should not apply for such seats to the Institutions/Colleges/ University or to the Ministry of Health & Family Welfare, Govt. of India. Such applicants for Central Pool Scheme should apply to following authorities only after obtaining the minimum marks in NEET-UG-2025.

(b) The applicants belonging to 'Central Pool Scheme' (NGOI) category for the Session 2025-2026 will be required to register online on or before the last date of admission.

<u>Note</u>: The College concerned may take necessary action pertaining to admission in the UG Courses (MBBS) under NGOI Quota (Central Pool Scheme) as per the relevant guidelines and verification of the details of the Nodal Officer of the respective state from the Ministry of Health & Family Welfare (MoHFW).

5. <u>Procedure for selection to MBBS/BDS Courses shall be as</u> follows :

The University of Delhi will not conduct a separate entrance examination for admission to MBBS/BDS courses under 85% Delhi Quota. Applicants are required to appear in NEET-UG 2025 conducted by NTA.

6. Display of merit list:

The counseling for admission to UG (MBBS/BDS) courses 2025 for 85% Delhi Quota and 15% All India Quota will be undertaken by Ministry of Health & Family Welfare. All applicants may regularly visit Ministry of Health & Family Welfare (Govt. of India) website: <u>www.mcc.nic.in</u> for regular updates.

7. Procedure for admission, assignment of College/Institution:

- a. The applicant will be required to produce admission tickets of NEET-UG 2025 and all original certificates including score card of NEET-UG-2025 at the time of admission to MBBS/BDS Course.
- b. The admission would be made strictly on merit on the basis of percentile of the eligible applicants in each category, determined by rank/ marks obtained in the NEET-UG-2025.
- c. As soon as a applicant is allotted his/her selected seat, they are required to register
 themselves online at https://fmsc.du.ac.in after verification of their documents from the respective college.

8. Counseling Schedule:-

The counseling for 85% Delhi Quota and 15% All India Quota shall be done by Ministry of Health & Family Welfare, Government of India through online mode. The applicants are required to fulfill

9. Counseling procedure:-

- (i) The counseling will be done by Medical Counseling Committee, Ministry of Health & Family Welfare, Govt of India and the applicants are advised to visit website of MCC (www.mcc.nic.in) for all updates and procedure relating to counseling.
- (ii) The left over seats if provided by MCC will be filled up through Stray Vacancy Round as and when notified.

- 11. <u>Resignation:</u>Regarding resignation /withdrawal of seats by the applicants, the rules guidelines of MCC shall prevail in letter and spirit.

12. <u>Surety Bond Money:-</u>

A bond worth **Rs.3** lakhs with two sureties should be executed by the applicants at the time of their provisional admission. The admission will not be valid unless and until the Surety Bond is executed by the applicant. The Performa of Surety Bond is available on website: <u>https://fmsc.du.ac.in</u>.

Rules regarding payment of Surety Money:-

- a. If a student surrenders seat in violation of MCC rules/instructions after joining the allotted institution.
- b. If the student leaves the courses before its completion.
- c. If the admission/registration of the student is cancelled/terminated by the University on account of unsatisfactoryperformance/misconduct /indiscipline.

The Original Certificates of the students would be kept in the custody of the admitting Institution and would be returned only after completion of the course or on payment of Surety Bond money, as the case may be. The **thirty percent** of the Bond Money thus collected will be deposited with the University (Faculty of Medical Sciences) by the institution and the rest could be utilized by the Institution for development of U.G teaching and training programmes.

Note : In case any student leaves the course by virtue of terms and conditions in the NMC/DCI Regulations and Ordinances of the University pertaining to Examination rules etc. then he/she will not be liable to pay the prescribed bond money.

13. Joining:

- a. The applicants, who have been admitted in a course, shall be required to join the assigned institution by stipulate date.
- b. The applicants must report to the college concerned by the date mentioned in their admission letter for completing the admission formalities at allotted college failing which his/ her admission is liable to be cancelled.

No Migration (to and fro) is permitted in the Medical College at the University of Delhi.

- (ii) The Persons with Benchmark Disabilities (PwBD) shall be exempted from payment of fee, including examination fee and other University fee, except Admission fee, subscription towards Delhi University Students' Union and Identity card fee. (vide DU circular no. Aca.I/082/2001/PwBD/2012-13/355 dated 13thSeptember, 2012)
 - (iii) The candidature for the Under-graduate MBBS/BDS courses in University of Delhi is strictly provisional and mere appearance at the National Eligibility Entrance Test (NEET-UG-2025), and registering online with www.mcc.nic.in/ Ministry of Health & Family Welfare (Government of India) as well as in University of Delhi will not entitle the applicant for admission, which will be subjected to the marks/merit of NEET- UG-2025 and applicant's fulfilling all the requirements for admission. Those applicants who are not eligible would apply at their own risk and would not be entitled for admission. If at a later stage it is detected that they are not eligible as per rules, the registration and admission of such applicants will be invalid and no refund of fee will be done under any circumstances.

Further, if any information furnished by the applicant is found fraudulent, incorrect or untrue, at any time during admission / course, he/she shall be liable to criminal prosecution; it will entail disqualification and shall render the applicant unfit for admission without any notice. The applicant shall abide by the Rules and Regulations of the University.

- **(iv)** The applicants shall have to comply with all the instructions while filling in the online registration form. Any error arising on this account shall be the responsibility of the applicants.
- (v) Applicants, before filling in online registration form, should satisfy themselves of their eligibility for admission to the courses. The applicants are required to go through the BOI carefully and

- (xi) No TA/DA is admissible for appearing in theAdmission/Counseling.
- (xii) Admission shall not be claimed by any applicant as a matter of right. The admission shall be entirely at the discretion of the Medical Counselling Committee (MCC), Directorate General of health Services, Ministry of Health & Family Welfare, Government of India and Medical Courses Admission Committee for UG (MBBS/BDS) of the University, which may refuse to admit any applicant without assigning any reason thereof.
- (xiii) In case of any dispute, the decision of the Medical Courses Admission Committee for UG (MBBS/BDS) shall be final. However, an appeal may be filed with the Vice- Chancellor, University of Delhi against such decision.
- (xiv) For all legal matters, the jurisdiction will be the National Capital Territory of Delhi only.
- (xv) The applicants must register themselves for online Counselling by the the stipulated date and time as per the Counselling Schedule notified by the MCC (Government of India) on its website (www.mcc.nic.in /Ministry of Health & Family Welfare (Government of India).
- (xvi) The applicants nominated by the Government of India (NGOI) having qualifications of a University/ Board which are not recognized by the University, should submit an equivalence certificate from the Association of Indian Universities (AIU). The admission of these students shall be subject to recognized by the University equivalent to 12th class examination under 10+2 system is contained in Appendix-I.

The span period including internship to complete MBBS Course will be as per the provision of MBBS Ordinance 2019 of the University :

<u>**Clause 7.1**</u>: Every very learner shall undergo a period of certified study extending over $4\frac{1}{2}$ acaemic years, divided into nine semesters from the date of commencement of course to the date of completion of examination which shall be followed by one year of compulsory rotating internship.

<u>Clause 7.7</u>: No more than four attempts shall be allowed for a applicant to pass the first Professional examination. The total period for successful completion of first Professional course shall not exceed four (4) years. Partial attendance of examination in any subject shall be counted as an attempt.

SECTION-B

IMPORTANT GUIDELINES FOR MBBS/ BDS COURSES

1. Reservations:-

A. Reservation of Seats for Schedule Caste (SC)/Tribe (ST)Applicants:-

Fifteen percent (15%) seats are reserved for applicants belonging to SC category and Seven & Half percent (71/2%) for ST category.

The SC/ST applicant should attach a certificate to the effect that he/she belongs to SC/ST category from any one of the competent authorities as listed below without which concession of reservation of seats for SC/ST will not be given:

- (a) District Magistrate/ Additional District Magistrate/ Deputy Commissioner/ Deputy Collector/ 1st Class Stipendiary Magistrate/ City Magistrate (not below the rank of 1st Class Stipendiary magistrate// Sub-Divisional Magistrate// Taluka Magistrate// Executive Magistrate/ Extra AssistantCommissioner.
- (b) Chief Presidency Magistrate/ Additional Chief Presidency Magistrate/ PresidencyMagistrate.
- (c) Revenue Officer not below the Rank of Tehsildar.
- (d) Sub-Divisional Officer of the area where the applicant or his/ her family normally resides.
- (e) Administrator/ Secretary to Administrator/ Development Officer (Lakshadweep Islands).

If the applicant happens to belong to SC or ST category, applicant's caste/ tribe must be listed in the appropriate Govt. of India Schedule. The Caste /Tribe Certificate should clearly state: (a) Name of his/ her caste/ tribe (b) whether applicant belongs to SC or ST (c) District and the State or Union Territory of applicant's usual place of residence, and (d) the appropriate Govt. of India Schedule under which his/ her caste/ tribe is approved as SC orST.

If the applicants do not have the SC or ST caste/tribe certificate at the time of registration/applying, the applicant may upload the acknowledgement slip of the SC or ST caste/tribe certificate application. However, at the time of admission, the applicant will have to produce the valid original SC or ST caste/tribe certificate.

The students belonging to SC/ST categories admitted to the various college departments of the University whose parents income was such that they are not paying income tax be exempted from the payment of the tuition fee and admission fee vide letter No. SPLC/ Fee exemp./SC/ST/2015-2016 dated 09.09.2015 & office letter no. Ref. No. Spl.Cell/2000.
- Note: 2 Reference to University circular no. Aca.I/SC/ST/2015/863 dated 12.11.2015& letter no. F.No. 14-5/2013-SC/ST dated 13/01/2015 Ministry of Education. Facilitating admission of deserving and eligible applicants facing financial constraint:-
 - (i) No fee need to be charged at the time of admission from those SC/ST students who are eligible for Post-metric Scholarship/Top class Scholarships. At the time of admission they may advised to deposit the fee with the Institute as soon as they receive the scholarship amount. An undertaking to this effect may be taken from them at the time of admission. However, the Centrally Funded Higher Education Institute (CFHEI) will responsible for timely verification, etc. of documents and their submission to facilitate timely disbursement of scholarship.
 - (ii) In other cases, if any SC/ST students failed to deposit the fee in the Institute then fee may be charged after making special efforts to get them requisite loan sanctioned, including facility of interest subsidy to those whose income is below Rs. 4.5 lakhs whereapplicable.
 - (iii) Special schemes under Schedule Case subplan /Trible Subplan (SCSP/TSP)may also be drawn, in consultation with the target group in respective Centrally Funded Higher Education Institute (CFHELs)/ for providing other facilities like book, equipment etc. essentially required for completion of course, which are not covered under those Scholarship Schemes, for SC/ST students.

B. Reservation of Seats for Other Backward Classes (Non-Creamy Layer, Central List):-

27% seats are reserved for applicants belonging to OBC category, while applying for admission to MBBS/BDS Course, should enclose a copy of the certificate alongwith the Application Form to the effect that he/she belongs to OBC Category duly certified by one of the competent authorities as listed below. However, the OBC status is to be determined on the basis of the Central List of OBCs notified by the Ministry of Social Justice and Empowerment on the recommendations of the National Commission for Backward Classes

The OBC applicant who belongs to Creamy Layer are not eligible for any concession applicable for OBC category applicants. The proof of non-creamy layer certificate issued by one of the Competent Authorities as mentioned above, should be uploaded with the online Registration Form.

C. Reservation of Seats for Persons with Benchmark Disabilities(PWBD)

As per Gazette notification dated 4.02.2019 issued by Government of India regarding Board of Governors in supersession of Medical Council of India related to Amendment Notification for guidelines regarding admission of students with "specified Disabilities" under the Rights of Persons with Disabilities Act 2016 with respect to admission in MBBS. (Appendix- H) 5% of the annual sanctioned intake capacity in Government or Government aided higher educational institutions shall be filled up by applicants with benchmark disabilities in accordance with the provisions of the Rights of Persons with Disabilities Act, 2016 based on the merit list of 'National Eligibility-cum-Entrance Test'. For this purpose the "Specified Disability" contained in the Schedule to Rights of Persons with Disabilities Act, 2016 and the eligibility of applicants to pursue a course in medicine with specified disability shall be in accordance with Appendix 'H'. If the seats reserved for the persons with disabilities in a particular category remain unfilled on account of unavailability of applicants, the seats shall be included in the annual sanctioned seats for the respective category.

4. In pursuance of the Executive Council Resolution No. 50 dated 03.11.2012, it is notified that the students with physical disabilities residing in different Hostels / Halls of the University are exempted from payment of all hostel fee and charges except refundable caution fee and the mess fee. The persons with Physical Disabilities shall pay 50% of the Mess fee and the remaining 50% of the Mess Fee-in respect of the PwBD students is being met by the University of Delhi. Similar norms are to be adopted by the Colleges in respect of PwBD Students residing in various hostels of theColleges.

It is clarified further that the PwBD students who are getting fellowships / financial assistance shall be exempted from payment of fee / charges / mess fee subject to the following conditions:

- (iii) The consolidated list of the registered candidates on the CW portal for entitlement under Delhi Quota (85%) shall be verified by the MCAC (UG) for their eligibility as per norms of the University of Delhi. The list of the candidates eligible for Delhi Quota (85%) shall be provided to the KSB, PMA Cell, MHA (for priority V (vii & x) and WARB, MHA (for the remaining Priorities Priority I to V only) alongwith the application forms and relevant documents for verification, as the case may be. The candidates who will not fulfill the eligibility criteria for Delhi Quota (85%) shall be excluded from the list with the remark "Outside Delhi candidate".
- (iv) The authorities of KSB, PMA Cell, and WARB, MHA will be responsible for addressing any grievances or litigations arising from the verification of CW/ECC certificates submitted by candidates through University of Delhi. The University of Delhi will not be held responsible for such issues.
- (v) The Issuing authority is responsible for the issuance of this certificate in accordance with the governing laws and regulations of the Ministry of Defence / Ministry of Home Affairs, as applicable.
- (vi) In the event of any issue/claim/dispute before the court of law in the matter of Priority assigned, the issuing authority shall defend the case, in the court of law and the University of Delhi shall be indemnified for such issue/claim/dispute.
- (vii) The provisional list of the eligible candidates for their entitlement under CW Category (Delhi Quota) duly verified by the KSB/MHA shall be forwarded to the MCC before the commencement of the Ist Round of councelling to conduct the counselling and to allot the seat on the basis of All India Rank, Category and Priority of the respective candidates for provisional admission subject to verification of the original documents by the concerned college at the time of reporting for admission by the selected candidate.

2. Prohibition and Punishment for Ragging: OrdinanceXVC:-

- Ragging in any form is strictly prohibited, within the premises of College/Department or Institution and any part of Delhi University system as well as on public transport.
- (ii) Any individual or collective act or practice of ragging constitutes gross indiscipline and shall be dealt with under thisOrdinance.
- (iii) Ragging for the purposes of this Ordinance, ordinarily means any act, conduct or practice by which dominant power or status of senior students is brought to bear on students freshly enrolled or students who are in any way considered junior or inferior by other students and includes individual or collective acts or practiceswhich-
 - (a) involve physical assault or threat to use of physicalforce;
 - (b) violate the status, dignity and honor of womenstudents;

- (c) violate the status, dignity and honor of students belonging to the scheduled castes and tribes;
- (d) expose students to ridicule and contempt and affect theirself-esteem;
- (e) entail verbal abuse and aggression, indecent gestures and obscene behavior.
- (iv) The Principal of a College, the Head of the Department or an Institution, the authorities of College, of University Hostel or Halls of Residence shall take immediate action on any information of the occurrence ofragging.
- (v) Notwithstanding anything in Clause (4) above, the Proctor may also *suo moto* enquire into any incident of ragging and make a report to the Vice-Chancellor of the identity of those who have engaged in ragging and the nature of the incident.
- (vi) The Proctor may also submit an initial report establishing the identity of the perpetrators of ragging and the nature of the ragging incident.
- (vii) If the Principal of a College or Head of the Department or Institution or the Proctor is satisfied that for some reason, to be recorded in writing, it is not reasonably practical to hold such an enquiry, he/she may so advise the Vice- Chancelloraccordingly.
- (viii) When the Vice-Chancellor is satisfied that it is not expedient to hold such an enquiry, his/her decision shall befinal.
- (ix) On the receipt of a report under Clause (5) or (6) or a determination by the relevant authority under Clause (7) disclosing the occurrence of ragging incidents described in Clause 3(a), (b) and (c) the Vice-Chancellor shall direct or order rustication of a student or students for a specific number of years.
- (x) The Vice-Chancellor may in other cases of ragging order or direct that any student or students be expelled or be not for a stated period, admitted to a course of study in a college, departmental examination for one or more years or that the results of the student or students concerned in the examination or examinations in which they appeared becancelled.
- (xi) In case any students who have obtained degrees of Delhi University are found guiltyunder this Ordinance appropriate action under Statute 15 for withdrawal of degrees conferred by the University shall beinitiated.
- (xii) For the purpose of this Ordinance, abetment to ragging whether by way of any act, practice or incitement of ragging will also amount toragging.
- (xiii) All institutions within the Delhi University system shall be obligated to carry out instructions/directions issued under this Ordinance, and to give aid and assistance to the Vice-Chancellor to achieve the effective implementation of the Ordinance.

(xiv) The Medical Council of India (presentation & prohibition of ragging in Medical Colleges/Institutions) regulations 2009 notified in the part III section 4 of the Gazette of India on 03.08.2009 amended from time to time be also adhered to.

3. Sexual Harassment:-

Sexual Harassment (Ordinance XV-D) has repelled by the Act passed by Parliament the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal)/ Act, 2013 (Ref. No. Estab.II(i)/27/ACC/2006 dated 09.01.2014. (www.wed.nic.in/wcdact/womenactsex.pdf).
