Subject: Conduct of the 3rd Round/Submission of Online Preferences for admission to NEET UG MBBS/BDS-2025 in various Government/Private Colleges/Institutions of the UT of J&K,

including the seats of SMVDIME/ASCOMS.

NOTIFICATION No. 153 -BOPEE of 2025 Dated 14-10-2025

Pursuant to Notification No. 137-BOPEE of 2025 dated 22-09-2025 and Notification No. 145-BOPEE of 2025 dated 07-10-2025, the Board has received a shortfall from various Government Medical/Dental Colleges of the UT of J&K after the conduct of the 2nd round of leftover seats of online counselling and 1st round of additional MBBS seats, respectively. To fill up these shortfall seats which have become available due to non-joining, resignation/surrender or remained vacant during these rounds of counselling along with the seats of Shri Mata Vaishno Institute of Medical Excellence (SMVDIME) / ASCOMS, it is hereby notified for information of all the concerned candidates that the Board shall conduct the 3rd Round (Upgradation/Allotment) of online counselling collectively w.e.f. 15-10-2025 (4:00 P.M. onwards) to 17-10-2025 (Midnight).

The following candidates shall be eligible to participate in the 3rd Round of Online (Upgradation/Allotment) Counselling:

- i. Candidates who did not get any seat in any of the previous rounds.
- ii. Candidates who have been allotted a seat during previous rounds and have joined the College/Institute.
- iii. Candidates who have been allotted a seat during any of the previous rounds but could not join due to any of the reasons, like deficient/invalid documents, non-submission of fee, non-reporting for admission, etc.
- iv. Candidates who have resigned from the allotted seat of previous rounds at the College/Institution.
- v. The eligible candidates who have qualified NEET UG (MBBS/BDS)-2025, registered with BOPEE, and have not participated during any of the previous rounds of counselling are also eligible for this round of counselling. They must deposit the counselling fee of Rs. 1500/- online and fill in the preferences for the 3rd Round of Counselling.
- vi. The candidates who have paid the online fee during any of the previous rounds shall not be required to pay any fee during this round of counselling.

vii. The candidates who have registered afresh in response to Notification No. 130 -BOPEE of 2025 Dated 16-09-2025, and Notification No. 139 -BOPEE of 2025 Dated 22-09-2025 and candidates who changed their category and accepted by the Board in response to the aforesaid notifications shall be eligible for newly added seats in private colleges and shortfall of additional seats in Govt. Medical Colleges/Institutions of the UT of J&K.

viii. Counselling for Management Quota under the Hindu Minority (HM) category and NRI Quota Seats shall be conducted separately at an appropriate time, as will be duly notified by the Board. Therefore, all eligible candidates are advised to regularly visit the official website of J&K BOPEE for the most recent updates related to this matter.

In this round, only vacant seats shall be filled from respective categories, as per where the shortfall has been received, i.e. the seats left out by the OM candidates during the 1st round shall be allotted to the OM candidates, and those left by the category candidates shall be allotted to the category candidates. As decided by the Board, the resultant vacancies that will accrue due to upgradation during the seat allotment process of this round shall be simultaneously allotted to the next eligible candidates based on the merit-cum-preferences. However, if a seat is allocated to a reserve category candidate by the application of rule 17 of the reservation rules in the 1 & 2 rounds, the seat so vacated shall be filled by an OM candidate based on merit cum preference.

The Seat Matrices for the said courses shall be available on the official website of the Board before the start of the online choice filling process.

Mere filling up of online preferences shall not confer any right of admission to any candidate unless and until their eligibility is verified by the colleges/institutions concerned, where they will be provisionally selected.

The other Terms and Conditions shall remain the same as mentioned in the e-Information Brochure / Notifications / Notices issued by the Board from time to time in this regard.
